



# **Open Enrollment Space Determination Plan for 2025-26 School Year**

The Menasha Joint School District uses the tables attached (Appendix A) to establish an annual staffing plan. These tables represent the information used to determine grade-level and special education staffing for the 2025-26 school year.

## For Open Enrollment purposes:

- Projected Enrollments will include resident students, tuition waiver students under 121.84 Wis. Stats., and open-enrolled students under section 118.51 (3) (a) who are currently attending.
- The district will use the high number in the given ranges when determining available space for open enrollment applicants, allowing for enrollment increases throughout the school year.
- Secondary space determinations are based on total school capacity.

## Application Consideration Process:

- 1. Determine if space is available in grade level
- 2. Students currently attending under a tuition waiver or currently attending that apply for open enrollment shall be approved.
- 3. Siblings of students currently attending will be given preference.
- 4. Determine if space is available in special education program, if needed, calculated with intensity scale
- 5. If space is not available in requested school, a different school with space at that grade level may be offered.
- 6. If space is not available in grade level, student will be placed on the waiting list.
- 7. If space is not available in special education program, student will be denied.

Open enrollment exception applications received outside the state-designated open enrollment window will be considered on a case-by-case basis using the same calculations at the time of application to determine current available space.

Students who are approved as a student without a disability who are referred and found eligible for special education services may be returned to their resident district. The decision will be based on space determinations made by the Board of Education.

#### **Special Education:**

The Menasha Joint School District uses the table below to establish an annual special education staffing plan. This table represents the information used to determine special education staffing for the 2025-26 school year. Our intent is to begin the school year at the low end of the range allowing room for newly identified district students throughout the school year.

OE requests for students receiving contracted services or attending a tuition-based off-campus program will be reviewed on a case-by-case basis, and acceptance will be based on the service availability in the district.

Special education space is calculated using a weighted scale based on each student's level of intensity. Students are weighted a 1, 2, 3, or 4 based on the amount of special education services identified in their IEP.

Due to the significant number of special education referrals at the PK-4<sup>th</sup> grade level, the number of projected students includes a 20% increase from actual student numbers. This was based on an analysis of the prior three years of referrals and placements made between January and June of the given years.

Speech and Language, Occupational Therapy, and Physical Therapy numbers are based on actual current enrollments. The students do not carry weighted values.
